

### **Remote Network Attack & Penetration Testing Services**

S.R. Snodgrass has historically performed internal network security Attack and Penetration testing at our clients' sites. To streamline the process, our IT Audit team **created remote keys that we ship to clients, allowing us to function exactly as if we were on site.** 

We stress the importance of a mix between automated software and manual tasks during Attack and Penetration testing. A simple preliminary call allows us to determine setup needs prior to shipping the remote key. **Clients need only to plug the remote key into their network and attach a power supply** to be ready for testing. Unlike most companies, we employ **seven layers of security features on these devices** to ensure the safety of our clients' networks and data.

# **FedLine Advantage Security and Resiliency Assurance Program**

For the new FedLine Advantage Security and Resiliency Assurance Program, there are 56 unique control areas that must be certified through a management attestation annually. These 56 controls cover security, operations, and policy and procedural items. Many controls require significant technical and IT expertise, as well as banking expertise, to know how to properly test the area in question.

In 2021, Snodgrass developed a unique set of audit programs to assist clients in this attestation. While we are not permitted to complete the official two-page attestation on behalf of management, we are able to assist in the testing of the 56 control areas, provide management a list of controls for which they must meet standards, and walk them through the attestation requirements. **Our IT Group has the expertise through combined years of experience and knowledge to provide exceptional performance standards for our clients.**
